#### HSE AWARD GUIDELINES

- 1. Each nominee must have been a staff member for more than 12 months. Nominations shall be for individuals only, not employee groups.
- 2. All nominations will be reviewed by HSSELQ Director's Office and HSE Corporate Office to ensure that the criteria are met and each nominee qualifies for recognition. Recognition should not be based on standard job performance.
- 3. Each nominee must have made an outstanding contribution to HSE on the job during the previous year.
- 4. A staff member is not eligible for the HSE award if he/she has a clear and specific primary responsibility for the department safety program as part of his/her normal job requirements.
- 5. A staff member is not eligible to receive an HSE award two years in a row. A staff member cannot receive an HSE award more than once based on the same acts of safety.
- 6. Corporate HSE Director and HSSELQ Director decision are final and cannot be contested.
- 7. When a recipient is chosen, the name shall be kept confidential under the HSSELQ Director's Office.
- 8. The recipient of the award shall be notified no more than one month and not less than two weeks in advance of the presentation, and the recipient at the same time shall be advised that the notification is confidential and that the recipient shall in no way divulge or publicize this notification.
- 9. The award shall be presented by Lusail CEO, QD HSE Sr. Director and HSSELQ Director.
